Verification and Certification	a licensed radio service, e.g.,	This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.
	§15.19(a)(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:	This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.
	§15.19(a)(3) All other devices shall bear the following statement in a conspicuous location on the device:	This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.
Additional Labelling For Verification Only	§2.954 Devices must be labelled with a unique identifier.	The identification format shall not be confused with the FCC ID label for certification.
Additional Labelling For Certification Only	§2.925(a) Each equipment covered in an application for equipment authorization shall bear a nameplate or label listing the following: (1) FCC Identifier consisting of the two elements in the exact order specified in Section 2.926. The FCC Identifier shall be preceded by the term FCC ID in capital letters on a single line, and
